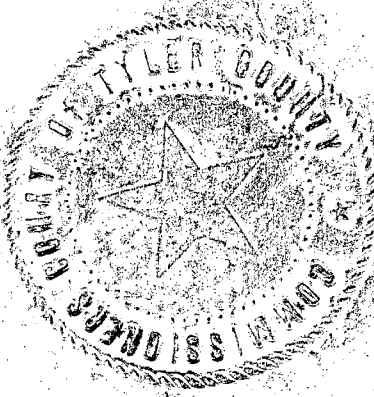

WHEREAS, Tyler County recognizes that the MH/MR facility in Jasper County serves the mentally retarded and mentally ill persons of Tyler County, and

WHEREAS, the existing MH/MR facility has served as a resource of the County in the capacity of developing and operating programs to meet the mental health and mental retardation needs of the County's residents, and

WHEREAS, this MH/MR facility has been totally destroyed by fire, and

WHEREAS, there are no other monies presently available from the County, foundations, government grants or other funding sources, and

WHEREAS, the Texas Department of Community Affairs has Community Development Discretionary Funds available which may be used for the construction of a building used to provide services to mentally ill and mentally regarded persons.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. That Tyler County supports the proposed activity described above and the application by Jasper County to construct a new MH/MR facility.
2. That Tyler County strongly urge TDCA and Governor Mark White to fund said application from Community Development Discretionary Funds.
