An Emergency meeting of the Commissioner's Court was held on Monday, April 13, 1987 at 2:00 P.M. All members being present. The meeting was opened with prayer by Commissioner Jordan.

A motion was made by Commissioner Jordan and seconded by Commissioner Barnes to set the closing date for accepting applications for County Judge on Monday, April 20, 1987 at 10:00 A.M. All voted yes and none no.

Commissioner Barnes made the motion that the court expect written applications of those who are interested. Interviews will start Monday, April 20, 1987 and will continue until all applicants have been interviewed by the court for appx. 30 minutes each. After all the applicants have been interviewed a date will be set by the court when the appointment of County Judge will be made. After each interview session, the court will reconvene to give the public an opportunity for questioning the applicants. The motion was seconded by Commissioner Conner. All voted yes and none no.

A motion was made by Commissioner Graham to authorize the County Treasurer and the County Auditor to make payments and write the checks for the quarterly reports and payroll deductions. (i.e. State Cost: Criminal Justice Tax, Crime Victims Compensation, and Judicial Education-Criminal; and TAC-Unemployment, workman's compensation and other fringe benefits from payroll) The motion was seconded by Commissioner Barnes. All voted yes and none no.

Commissioner Graham made a motion that the Commissioners approve the payroll sheets of all departments and that they be signed by the Commissioners on the day that payroll sheets are due. The motion was seconded by Commissioner Jordan. All voted yes and none no.

A motion was made by Commissioner Jordan and seconded by Commissioner Graham that the meeting adjourn.
