The Regular Meeting of the Commissioner's Court was held on Monday, April 13, 1987 at 10:00 A.M. All members being present. The meeting was opened with prayer by Commissioner Jordan.

A motion was made by Commissioner Jordan and seconded by Commissioner Graham to approve the County Extension monthly report. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Jordan to table approving the County Treasurer's monthly report until Thursday, April 16, 1987 at 10:00 A.M. The motion was seconded by Commissioner Barnes. All voted yes and none no.

Commissioner Graham made a motion to approve the monthly report from the Probation Department. Commissioner Conner seconded this motion. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Graham to table accepting the monthly report of J.P. #1, Wanda Brasher until Thursday's meeting. This would give Judge Brasher more time to submit the report. The motion was seconded by Commissioner Barnes. All voted yes and none no.

Commissioner Barnes made a motion to table approving the County Auditor's monthly report until Thursday's meeting. The motion was seconded by Commissioner Conner. All voted yes and none no.

A motion was made by Commissioner Graham and seconded by Commissioner Jordan to approve the monthly travel and allowances for county officials as submitted by the County Auditor, Janie DuBose. All voted yes and none no. SEE ATTACHED.

Commissioner Jordan made a motion to grant permission to the County Treasurer to attend an accreditation seminar in College Station, Texas on April 20-23, 1987. The motion was seconded by Commissioner Graham. All voted yes and none no.

Commissioner Graham made a motion to approve the deputation of Dale Davis in the County Clerk's office. This is filling in an opening in the clerk's office since January 1, 1987. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Graham and seconded by Commissioner Barnes to approve the plaque for the Justice Center with the correction that the names of Commissioners be placed in order of the respective precincts. All voted yes and none no. SEE ATTACHED.

Commissioner Jordan stated that he hated to see the Judge go - that he had done a fine job for Tyler County, but he understood. All voted yes and none no. SEE ATTACHED.

Commissioners stated that a deadline for applications will be set at the meeting on Thursday, April 16, 1987.
