The Regular Meeting of the Commissioner's Court was held Monday, May 11, 1987 at 10:00 A.M. All members being present. The meeting was opened with prayer by Dr. Mouzon Biggs, pastor of the Boston Avenue Methodist Church, Tulsa, Oklahoma.

A motion was made by Commissioner Jordan and seconded by Commissioner Graham to table approving the County Extension monthly report until Friday, May 15, 1987. All voted yes and none no.

Commissioner Barnes made a motion to table approving the Probation monthly report, County Treasurer's monthly report, County Auditor's monthly report and the monthly report from J.P.#1, Wanda Brasher until Friday, May 15, 1987. The motion was seconded by Commissioner Graham. All voted yes and none no.

A motion was made by Commissioner Jordan to authorize the County Auditor to pay \$625.00 to the Lion's Club for the purchase of light bulbs. Commissioner Graham seconded this motion. All voted yes and none no. SEE ATTACHED.

The County Auditor, Janie DuBose, also presented to the court a bill for maintenance of the computer for the District Judge. Tyler County's portion of 25% would be \$ 130.00. Jasper County also pays a portion of charges for this computer.

A motion was made by Commissioner Graham and seconded by Commissioner Conner to authorize the County Auditor to reallocate funds from the purchase price line item of the budget into a maintenance item. All voted yes and none no. SEE ATTACHED.

Commissioner Barnes made a motion to approve the payment of monthly travel and allowances as submitted by the County Auditor. The motion was seconded by Commissioner Graham. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Barnes and seconded by Commissioner Conner to table approving the easements to Gulf States Utilities Co. at the jail site until it could be discussed with the sheriff and the Criminal District Attorney. All voted yes and none no.

Commissioner Barnes made a motion to table the item permitting the sheriff to sell 1983 Chevrolet pickup truck until Friday by request of Sheriff Fowler in order that this item can be taken up at the same time adding a Ford Crown Victoria to be bidded also. Commissioner Graham seconded this motion. All voted yes and none no.

A motion was made by Commissioner Jordan to allow the Tax Assessor-Collector, Barbara Tolbert to purchase \$ 1500.00 postage for the postage meter when the level reaches \$ 40.00 and also authorizing the County Auditor to write the check for same. The motion was seconded by Commissioner Barnes. All voted yes and none no.

Commissioner Jordan made a motion to defer discussion of the Sheriff's \$400.00 vehicle allowance and also the salary of the Chief-Deputy, Wade Skinner until the court could get an opinion from the Criminal District Attorney. Since these items are in the 1986-87 budget they will be considered when the upcoming budget is under consideration. The motion was seconded by Commissioner Conner. All voted yes and none no.

A motion was made by Commissioner Graham to accept the petitions from residents of Fox Bend Road and to file them with the County Clerk, causing improvements asked for to be made at the discretion of Commissioner Graham within the budget limitations. The motion was seconded by Commissioner Jordan. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Jordan to adjourn the meeting. The motion was seconded by Commissioner Conner. All voted yes and none no.
