An Emergency Meeting of the Commissioner's Court was held on Monday, August 17, 1987 at 1:00 P.M. All members being present.

A motion was made by **Commissioner Graham** and seconded by **Commissioner Barnes** to authorize **Judge Wheat** to execute and negotiate the **Title III -B Aging Fund Grant** from DETCOG. All voted yes and none no.

ACTION TAKEN IN SPECIAL MEETING/BUDGET HEARING:

Commissioner Barnes made a motion that no raise be given to **county employees or officials** until the county is in better shape. The motion was seconded by **Commissioner Conner**. All voted yes and none no.

Commissioner Jordan made a motion to defer consideration of request of **County Treasurer** for a secretary until this could be discussed with the County Treasurer, Jean Phillips. **Commissioner Barnes** seconded this motion. All voted yes and none no.

A motion was made by **Commissioner Graham** and seconded by **Commissioner Jordan** that the increase in car allowance requested by **Justice of Peace, Pct. #1-Wanda Brasher**, be denied. All voted yes and none no.

A motion was made by **Commissioner Graham** and seconded by **Commissioner Conner** that the increase in car allowance and office allowance requested by **Justice of Peace, Pct. #4-Roy Drake** be denied. All voted yes and none no.

Commissioner Jordan made a motion to allow \$1200.00 to be divided among the four **constables** for the furnishing of uniforms. **Commissioner Graham** seconded this motion. **Commissioner Conner** stated that he would have to vote against this motion. After more discussion, **Commissioner Barnes** moved that this item be deferred until the next workshop for further study. All voted yes and none no.

A motion was made by **Commissioner Graham** to defer the consideration of book binding for the **County Clerk's** department until the next workshop. **Commissioner Barnes** seconded this motion. All voted yes and none no.

A motion was made by **Commissioner Jordan** and seconded by **Commissioner Graham** to approve the microfilming of the **District Clerk's** records in an amount not to exceed \$3000.00. All voted yes and none no.

Commissioner Graham made a motion to deny the request from the **County Judge** for an increase in car allowance. The motion was seconded by **Commissioner Conner**. All voted yes and none no.

Commissioner Graham made a motion that the meeting adjourn. The motion was seconded by **Commissioner Conner**. All voted yes and none no.
