A motion was made by Commissioner Jordan and seconded by Commissioner Graham to approve the monthly report from the County Extension department. All voted yes and none no. SEE ATTACHED REPORT.

This application is for the construction of a boat ramp at the Rockland river bridge. Commissioner Barnes seconded this motion. All voted yes and none no. SEE ATTACHED RESOLUTION.

A motion was made by Commissioner Jordan to defer consideration of payment to A.I.D. Architects until Friday, March 18. The motion was seconded by Commissioner Graham. All voted yes and none no.

A motion was made by Commissioner Jordan and seconded by Commissioner Graham to defer consideration of payment to Beaumont Telephone & Equipment Co. for the telephone system at the Tyler County Justice Center, until Friday, March 18, 1988. All voted yes and none no.

Commissioner Jordan made a motion to accept the Auditor's Annual Report for FY87 as printed. Commissioner Graham seconded this motion. All voted yes and none no. SEE ATTACHED REPORT.

A motion was made by Commissioner Barnes that Commissioner Jordan be designated as the County's representative on the Deep East Texas Resource and Recovery Advisory Committee. The motion was seconded by Commissioner Graham. All voted yes with Commissioner Jordan remaining silent. Commissioner Jordan made a motion to adopt the resolution supporting, participating and cooperating with Jasper County in their application for funds for a Regional Resource Recovery Feasibility Study.
