Vicki Thompson reported to the Court the status of the Tyler County Children's Services Board. She made them aware of the benefits to the children of Tyler County. A motion was made by Commisisoner Graham to appoint Elaine Clow, Dee Brown, John Tucker, Beverly Brown, Carolyn McGuire, Jim McWilliams, Vicki Thompson, Jane Silvey, Dena Conner and Jo Shepherd as members to the Tyler County Children's Services Board. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED.

A motion was made by **Commissioner Conner** and seconded by **Commissioner Barnes** to ratify the by-laws as adopted by the **Tyler County Children's Services Board.** All voted yes and none no. SEE ATTACHED BY-LAWS.

**Commissioner Graham** made a motion to adopt the order approving the financing by **Kirbyville Health Facilities Development Corporation** of a **health facility** located at 1201 Cardinal Dr. in Woodville. The motion was seconded by **Commissioner Barnes**. Judge Wheat stated that this would be no cost to the County; that the Court was just agreeing that they did not have objections of them taking over the facility; the County does not have any liability. All voted yes and none no. SEE ATTACHED ORDER.

Richard Rankin and Alvin York talked to the Court about constructing a hangar beside the one that has recently been built. Judge Wheat advised them that there were problems with that site, however a study was being made by an engineer and the design would give a better idea for such. No action was taken. Consideration of application for construction of hangar at the Tyler County Airport would be discussed at the next meeting.

J.W. Ray introduced John Fiskell with Travelers Insurance who explained the increase and new rates of the insurance for employees. Judge Wheat recommended that J.W. Ray explore the possibility of finding another company that could give the same coverage at a less expensive rate. A motion was made by Commissioner Jordan and seconded by Commissioner Barnes to appoint J.W. Ray as agent of record for the purpose of obtaining bids on group life and health and to secure information on other insurance for County employees. Also, that the County renew its present policy plan with Travelers Insurance Co. until Mr. Ray can make a recommendation as to a better plan. All voted yes and none no. SEE ATTACHED.

Commissioner Jordan stated that the position of **jail administrator** was created to get the jail started and organized; that this was a temporary position. Commissioner Conner stated that he would like this matter deferred until he could speak with the jail inspector tomorrow at the jail inspection. This matter deferred until Thursday, July 14.
