A motion was made by Commissioner Mahan and seconded by Commissioner Jordan to approve paying the bill from Barnes Plumbing (#65146) for \$31.50. All voted yes and none no.

Carolyn Foster, CPA with Monroe, Culbreth and Associates, P.C., summarized the audit for FY88. Commissioner Riley moved that the Audit Report be accepted. Commissioner Mahan seconded this motion. All voted yes and none no. SEE ATTACHED ANNUAL FINANCIAL REPORT.

Commissioner Mahan made a motion to table action until the Criminal District Attorney has reviewed and proposed these resolutions or amendments to the resolutions for consideration by the Commissioner's Court on the 27th day of April. Commissioner Riley seconded this motion. All voted yes and none no.
