## COURT BACK IN SESSION:



A motion was made by Commissioner Barnes and seconded by Commissioner Riley to table discussion and action on the sanitary landfill in Chester area until Friday, August 18. All voted yes and none no.

A motion was made by Commissioner Barnes to approve the offer from Champion International for the removal of road material by Tyler County pursuant to a proposal addressed to the County Judge on August 3, 1989 relating to the G.L. Martin Survey, Abst. 452. Commissioner Riley seconded this motion. All voted yes and none no. Commissioner Barnes added his appreciation to Champion for their generosity. SEE ATTACHED PROPOSAL.

A motion was made by Commissioner Mahan to adopt a resolution concerning the 9-1-1 Emergency Telephone Number as read authorizing the changes and modifications to the resolution previously adopted by the County. Janie Marquiss presented a certificate of Continuing Education Units of 21 hours to the County Treasurer, Jean Phillips. SEE ATTACHED CERTIFICATES.

Bobby Gibson gave several proposals to the Court on managing the sanitary landfills: Compactors/recycling; Dumpsters; or Garbage trucks at each landfill. Judge Owens advised that Mr. Gibson prepare a proposal package for long term solutions to present to the Court in the future. No action was taken,

Jackie Skinner presented solicited bids for carpet and mini blinds for the County Auditor's department. After comments, a motion was made by Commissioner Jordan and seconded by Commissioner Barnes to table this matter until Friday, August 18. All voted yes and none no.

Donece Gregory submitted her resignation as Tax Appraisal Board representative. Judge Owens recommended that a member of the Commissioner's Court be appointed to the next term of office. motion was made by Commissioner Mahan and seconded by Commissioner Riley to nominate Commissioner James R. Jordan by resolution to the Tax Appraisal Board of Directors. and none no. SEE ATTACHED LETTER AND RESOLUTION.

A motion was made by Commissioner Jordan and seconded by Commissioner Riley to approve the bond of the County Auditor, Joyce Moore. All voted yes and none no. SEE ATTACHED BOND.

John Yearwood presented resolutions establishing the plan for a local emergency management program and establishing a criminal penalty up to \$1000 for the misuse of emergency devices giving false information. These resolutions were read to the Court in their entirety. A motion was made by Commissioner Riley to authorize the County Judge to sign these resolutions and have a second reading of same. Commissioner Barnes seconded this motion. All voted yes and none no. SEE ATTACHED CERTIFICATE AND RESOLUTIONS.

Elaine Clow submitted bills from the Child Welfare Board for physicals required by law for a foster child to be adopted. A motion was made by Commissioner Jordan that the bills be approved for payment in the amount of \$1040.00 to come from combined funds of Foster Child Care. Commissioner Barnes seconded this motion. All voted yes and none no.

Commissioner Riley made a motion to authorize the County Judge to make appointments of Commissioners to Fire District #2 these being Tom Harvey, Harold Youngblood, Dale Hinsley, Tom Cappel, and Garland Terry. Commissioner Barnes seconded this motion. All votes yes and none no. SEE ATTACHED LETTERS.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to allow the County Auditor and the District Clerk to attend the T.A.C. conference on August 16-18. All voted yes and none no.

A motion was made by Commissioner Jordan and seconded by Commissioner Mahan to allow the Veteran's Officer, David Enloe, to attend a conference in Dallas on September 26-29. All voted yes and none no.

Commissioner Riley made a motion which was seconded by Commissioner Barnes to table approving the purchase of one mini blind for the Commissioner's Courtroom until Friday, August 18. All voted yes and none no.

Juvenile Probation Officer, Betty McBride extended to the Court her anxiousness of getting designated office space for the juvenile department resolved. Upon Mrs. McBride's recommendation, a motion was made by Commissioner Riley and seconded by Commissioner Mahan to designate the employee's lounge area plus two rooms of the Extension Department as the Juvenile Department. Additionally, that \$200 to \$225 be allowed for Bill Jefferson to move the phones. All voted yes and none no.

Commissioner Jordan made a motion to approve Sheriff Hennigan using money from the sale of vehicles from his department to be used to repair vehicles now in use. This money would go back into the Sheriff's budget for such repairs. Commissioner Mahan seconded this motion. All voted yes and none no.

The County Clerk opened the one bid received for a generator in Doucette being from Double C Electric. A motion was made by Commissioner Riley and seconded by Commissioner Mahan to table action until Friday, August 18. All voted yes and none no.

A motion was made by Commissioner Barnes to approve the budget amendments (transfers within the departmental budgets) as presented, those being from Precinct 2, Precinct 3 and Jury Account. This motion was seconded by Commissioner Mahan. All voted yes and none no. SEE ATTACHED LINE ITEM TRANSFERS.

Mr. Ray presented some alternate plans that would reduce the premium cost. A motion was made by Commissioner Mahan to adjust the insurance coverage beginning August 1 to include a \$500.00 deductible/\$500.00 supplemental accident in full/second surgical opinion in full having a total health premium combined with a total life premium of approximately \$329.00. This motion was seconded by Commissioner Riley. All voted yes with the exception of Commissioner Jordan abstaining.

Donece Gregory, County representative to the Tax Appraisal Board of Directors presented her objections to the budget of the Appraisal District. She stated that she wished the Board would have not allowed salaries of employees to exceed the salary schedule adopted by the Board. Commissioner Riley asked for a comparison of Appraisal District salaries with that of County salaries showing all benefits. A motion was made by Commissioner Riley and seconded by Commissioner Mahan to table consideration of adopting the 1990 budget of the Tax Appraisal District until Friday in order that the Court could compare the budget with that of last year. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Mahan that the meeting adjourn. All voted yes and none no.
