Judge Owens welcomed guest and explained that matters concerning litigation involving the County and officials of the county in their official capacity are ordinarily covered in executive session outside the presence of the public. The closed session will be for discussion only and the Court will reconvene in open court to take action. Judge Owens asked that all persons present step outside the courtroom with exception to Sheriff Hennigan and Criminal District Attorney, Pat Hardy.

AFTER ADVISEMENT OF THE CRIMINAL DISTRICT ATTORNEY, PAT HARDY, THE COURT ENTERED INTO EXECUTIVE SESSION...10:03 A.M.

COURT RECONVENED IN OPEN SESSION...11:15 A.M... to discuss a lawsuit filed against the Parks and Wildlife and other individuals including Gary Hennigan individually and in his official capacity .

Judge Owens explained that the County was obligated to file an answer within 20 days in response to the lawsuit filed against Mr. Hennigan in his official capacity, which brings the County in as a participant in this lawsuit to the extent that defense will be required to be made on behalf of the County's interest. The Court is also obligated to insure that the County has full and complete representation during the initiation of this lawsuit.

Pat Hardy added that he intends to answer the suit and represent Sheriff Hennigan; however due to the possibility that Mr. Hardy is; called as a witness he may need some help with outside counsel. Judge Owens asked for the general policy concerning hiring additional counsel. Mr. Hardy responded that the policy had always been that the County hire outside counsel, with the exception of one case, and he saw no reason to differentiate from that now.

A motion was made by Commissioner Mahan and seconded by Commissioner Riley to authorize the Criminal District Attorney, County Judge and County Sheriff to meet and discuss hiring counsel to represent the Sheriff after his consultation, and such counsel be employed to represent the County, assisting the Criminal District Attorney, in the prosecution of the law suit filed in Federal Court in Lufkin, Texas and as further directed by the Commissioners' Court.
