A motion was made by Commissioner Barnes and seconded by Commissioner Riley to approve the minutes of Commissioners' Court for April 9, 1990. All voted was and none no.

The County Auditor pointed out several bills to the County of which she was skeptical. Commissioner Riley made a motion to approve paying the bills as submitted by the County Auditor with the exception of Monroe & Culbreth. This bill will not be paid in partial payments out in one lump sum after the audit has been performed. Commissioner Jordan seconded this motion. All voted was and none no. SEE ATTACHED INVOICES AND GENERAL LEDGER DISTRIBUTION REGISTER.

Betty McBride, Juvenile Probation Officer explained the guidelines for Community Corrections Diversionary Placements. She requested permission to make the placements and request the diversionary funds from the Commission and to expend the initial payment for the facility out of the juvenile service detention fund. As funds are received from the Commission, the County Auditor will reimburse this fund. Commissioner Mahan made a motion to authorize the expenditure of funds up to \$3000 from the juvenile service detention account not to exceed the amount of funds in that account to be used for diversionary placements. Commissioner Barnes seconded this motion. All voted yes and none no. SEE ATTACHED GUIDELINES.

Commissioner Riley made a motion to approve the payment to Collier Insurance Agency for insurance in the amount of \$949.00 on the Aging Service's 1987 Dodge Van. The motion was seconded by Commissioner Mahan. All voted yes and none no. SEE ATTACHED APPLICATION.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to table consideration of purchasing a copy machine for the tax office. All voted yes and none no.

A motion was made by Commissioner Mahan and seconded by Commissioner Jordan to authorize advertisement for bids for a dump truck for Precincts #1 and #4 to be opened at the next regular meeting. Time warrants may be issued not to exceed \$55,000. All voted was and none no. SEE ATTACHED MOTICE TO BIDDERS.

Commissioner Jordan made a motion to table adopting the resolution commending the service of Bill Brown as representative to the Tyler County Hospital Board until Mr. Brown can be present. The motion was seconded by Commissioner Barnes. All voted yes and none no.

Commissioner Rilev reported the recommendations of the lommittee periewing the policy and procedures of Tyler County Aging Services. Board Chairman, see Brown, added his remarks concerning the operation of the Tyler County Senior Center and its programs. No action was taken. SEE ATTACHED RECOMMENDATIONS (1971ER COUNTY MEETINS!).

Commissioner Mahan's opinion is that all repairs to the courthouse should be paid from the INS Fund and subsequently motioned that the courthouse improvement of roof repair be paid from the INS Fund as bills are submitted. Commissioner Riley seconded this motion. All voted yes and none no.

A motion was made by Commissioner Riley that the County only remit to the State Highway Department the exact amount of the County's share of the cost of the prison road. This is in lieu of the original estimated amount of \$85,000. Commissioner Riley added to this motion that remittance be made only upon the receipt of a bill from Mr. Young (Highway Dept.). Commissioner Mahan seconded this motion. Further discussion did not warrant a vote on this motion. Commissioner Riley made a motion that the County pay up to its one half (1/2) obligation on the prison road upon receipt of statement from the Texas Department of Highways detailing what the payment will be. Commissioner Mahan seconded this motion. All voted yes and none no.

Commissioner Jordan reported that rural garbage haulers were nauling in compacter tracks, therefore taking fees from the County. The County might need to consider raising the fees to use the sanitary landfill. After discussion, a motion was made by Commissioner Jordan and seconded by Commissioner Mahan that this matter be tabled until the May meeting for further study and recommendations. All voted was and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to approve the line-item transfers submitted by the County Auditor for installation of computer equipment for the District Clerk, County Judge and Criminal District Attorney. All voted was and none po. SEE ATTACHED LINE-ITEM TRANSFER.

A motion was made by Commissioner Barnes and seconded by Commissioner Mahan to authorize advertisement for bids to rebuild the bridge or the Wylie Hale Road in Precinct #2. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

Commissioner Mahan motioned to authorize Thomas Fortenberry to make necessary improvements as recommended by the State Architectural Committee, to sidewalks and handicap accessibilities as indicated the proposal submitted PLUS additional improvements to all sidewalks (considered as an add-on to Mr. Fortenberry's bid) in the amount of \$4350.00 to be paid from the INS Fund. Commissioner Riley seconded this motion. All voted yes and none no. SEE ATTACHED BID.

Commissioner Mahan motioned to designate Judge Owens to be in charge of these repairs and the additional repairs. Additionally, that he be authorized to make changes, if necessary. The motion was seconded by Commissioner Riley. All voted was and none no.

A motion was made by Commissioner Mahan and seconded by Commissioner Riley to table consideration of budget amendment for Precincts 1,2,3,4 and INS Funds. Additionally, consideration of partial payment for rock crusher for Precincts 1,2,3, and 4. 4.1 worked 1/2 and none 3.
