A motion was made by Commissioner Riley and seconded by Commissioner Mahan to accept the bid from "Jiggs" Evans in the amount of \$426.00 to construct a rolling table and removable podium for the District Courtroom. All voted yes and none no. SEE ATTACHED BID.

Commissioner Mahan motioned that Humble Elevator Service, Inc. install an Emergency Power pak and two roller guides on the elevator in the amount of \$637.50. Commissioner Riley seconded this motion. All voted yes and none no. SEE ATTACHED LETTER.

Sheriff Hennigan introduced Sheriff Mike Holzapfel from Hardin County. Sheriff Holzapfel disclosed a \$440,000 grant he received to form a Drug Task Force in Southeast Texas. The State will provide \$330,000 and \$110,00 (25%) will be in matching funds from agencies participating in the task force. Staff will consist of six narcotic officers; one secretary and one analyst. One officer will be assigned to the Woodville/Tyler County area. Hardin County provides the liability insurance. Tyler County's allocation would be \$25,000, becoming due in March 1991. Seizures will reduce this cost to the agencies. Consensus of the Court was to participate in the program if funds could be found and it would not conflict with the present participation in the Nacogdoches Task Force. After questioning by Court members, a motion was made by Commissioner Riley and seconded by Commissioner Barnes to table consideration of entering into the task force until May 29, 1990 at 1:00 P.M. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Jordan that the meeting adjourn. All voted yes and none no.
