Commissioner Mahan, chairman of the insurance committee reported that the committee recommended the County go out for bids for insurance. Other recommendations were: a 90 day waiting period for coverage on new employees; keep deductible at \$500.00; 80% coverage extended to next \$5000.00; Bid two options concerning dependant coverage (1- County pay premium of dependant coverage 2- Employee pay premium of dependant coverage); New employees must have a physical at County's expense; Underwriter for drug abuse, psychiatric care, and alcoholism.

A motion was made by Commissioner Mahan and seconded by Commissioner Riley to approve advertisement for bids for medical and life insurance. The bids will be opened on July 23 with specifications to be established by the insurance committee. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

A motion was made by Commissioner Jordan and seconded by Commissioner Riley to approve advertisement for bids for a new diesel dump truck for Precinct #4. The dump truck possibly will be paid for with two time warrants not to exceed \$30,000. The remainder will be paid with cash. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

After discussion concerning EPA regulations and new mandates, Commissioner Mahan motioned and seconded by Commissioner Riley to continue to issue garbage permits for solid waste another 6 months. All voted yes and none no.

A motion was made by Commissioner Mahan and seconded by Commissioner Barnes that the meeting adjourn. All voted yes and none no.

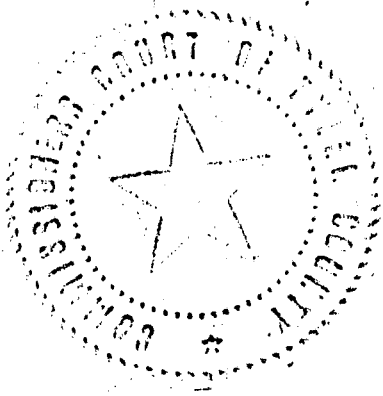
