Judge Owens answered stating that the County has not done away with that position and have continued to budget for that office. Bob Armentrout stated that the County must meet the level of funding which would be an increase of \$680.00, before the position could be filled. After discussion as to the budget items that were increased, Commissioner Mahan suggested the Court proceed with the budget and that members of Commissioners' Court talk to a representative from A&M Extension to work this out.

Upon satisfaction that the budget was balanced, Commissioner Jordan motioned to adopt the 1991 Budget as prepared by the County Auditor and worked on by Commissioners' Court. The motion was seconded by Commissioner Mahan. All voted yes and none no. SEE ATTACHED BUDGET.
