A written statement, was presented and read by Betty Jo Davis to Commissioners Court-concerning the extension of Highway 92 through the Dam B area. Present with Mrs. Davis were 15 other Tyler County residents who were also concerned with the extension of Highway 92. Mrs. Davis' statement asked the Commissioners Court the current status on the resolution that was unanimously agreed on in October 1989. Mrs. Davis persistently requested the Commissioners' Court to make.an appointment with the Texas Highway Commission, Sen. Bill Haley, State Representative, Allen Hightower and concerned residents to ask for a right-of-way study and further action to complete this highway extension. Commissioner Mahan responded to the group telling them that the Highway Commission has the esolution and no definitive action has been taken. Judge Owens responded to the group telling them that he, Commissioner Manan and Commissioner Riley had talked with the State Highway Engineer, Arnold Oliver, last Monday and asked if the survey could be started. Mr. Arnold told them that he was going to meet with the Commission on Wednesday and the project would be discussed but no definite action would be taken. Mr.Arnold explained that nothing could be done about the survey until there was a project number and before they can have a project number the Highway Commission must determine they will build the road. Judge Owens also explained to the group that the one thing in their favor was the fact that this portion of highway has been stubbed out and the Highway Department does not like to leave a portion of a stubbed out highway. He also told the group that he would prefer to set up a meeting for Senator Bill Haley and Representative Allen Hightower to come to Tyler County. Commissioners Court assured the group that they are very concerned about the highway extension and would continue to work for extension and present it to the State at the appropriate time.
