Commissioner Riley motioned to table the consideration on the bids for the County bank depository until Judge Owens returns; further, Judge Owens can set up a meeting strictly for the consideration of bids on the bank depository. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to accept minutes from the January 18 meeting as submitted. All voted yes and none no.

Commissioner Riley made the Court aware of the expenses incurred for the trip to Oklahoma to recover his stolen truck and this would be submitted to be paid with hopes of getting restitution. Commissioner Mahan told Commissioners' Court there were two mechanics from Houston that did not finish the work on equipment and they were furnished a hotel room at County expense in the amount of \$68.65. The motion was then made by Commissioner Riley and seconded by Commissioner Sawyer to approve paying bills submitted by the County Auditors Office, also with approval of insignia for the D.A.'s door. All voted yes and none no. SEE ATTACHED GENERAL LEDGER DISTRIBUTION REGISTER.

Commissioner Riley told Commissioners' Court that INS has a new contract. He explained that when you take an INS prisoner to the hospital and doctor that INS was receiving several different bills. INS would like to change the contract so that the County would pay the bills on the prisoners and INS would then reimburse the County for all expenses incurred. Sheriff Hennigan stated that the rates were going up from \$47.50 to \$52.50 with a difference of \$2,250 per month based on 15 inmates. Fifteen inmates cost approximately \$1,000 minimum. The motion was then made by Commissioner Riley to approve a change of agreement with INS subject to the District Attorney's approval. The motion was seconded by Commissioner Barnes. All voted yes and none no.

Sheriff Hennigan recommended to the Court that \$25 per hour be paid to the stockman with a minimum of 1 hour and \$5 per animal, per day storage. It was also recommended that the owner of the animal pay directly to the stockman. Commissioner Riley made the motion that the contract be drawn up by the District Attorney on the setting of fees for a stockman and reviewed by Commissioners' for approval. The contract must state that the County will be relieved of any liability. Commissioner Barnes seconded the motion. All voted yes and mone no.

Commissioner Riley made the motion that Jerry Mahan remain as a member on the Housing Finance Corporation Board. The motion was seconded by Commissioner Barnes. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Mahan to approve the Sheriff's projection of the Drug Seizure Budget for 1991. All voted yes and none no. SEE ATTACHED PROJECTION.

Commissioner Riley made the motion to approve Judge Owens to sign the contract between Tyler County and Texas Department of Commerce for the grant for road work in Precinct #1. All voted yes and none no. SEE ATTACHED CONTRACT.

A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to accept bids from Matthews Construction as the contractor for paving County roads. Based on location and that they would pave roads irregardless of the limited amount of road. All voted yes and none no.

Commissioner Riley made a motion to reject all bids on the cleaning of uniforms for the Sheriff's Department. He then stated that the Sheriff's Department should make a decision after consideration of service and price. The motion was seconded by Commissioner Barnes. All voted yes and none no. A motion was made by Commissioner Barnes and seconded by Commissioner Sawyer to re-advertise for bids on the used dump truck for Precinct #3. All voted yes and none no.
