Commissioner Riley made the motion to defer approval of minutes until June 3, 1991. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

The County Auditor questioned certain bills that needed invoices and a duplication of billing (invoice #98678 was struck). A motion was then made by Commissioner Riley and seconded by Commissioner Sawyer to pay the bills from the County Auditor's Office as submitted with the exceptions of #98678 and Mustang pending invoice to be submitted by Commissioner Mahan. All voted yes and none no with Commissioner Barnes abstaining from any vote on #98 628. SEE ATTACHED GENERAL LEDGER DISTRIBUTION REGISTER.

A motion was made by Commissioner Sawyer and seconded by Commissioner Barnes to advertise for bids to sell a 1978 GMC 6500 truck without bed and a 1976 Chevrolet 1/2 ton truck from Precinct #4. It was noted that the used vehicles can be viewed at Precinct #4 County Barn from 6:00 A.M. until 4:30 P.M. Monday through Thursday with the bids to come in no later than June 15 at 10:00 A.M. Commissioner Riley made the motion to authorize Barbara Tolbert, Tax-Assessor Collector, to solicit proposals for two typewriters to be paid for out of the General Fund with the bids being opened on June 10. The motion was seconded by Commissioner Barnes. All voted yes and none no.
