The invocation was delivered by Tom Sturdivant, Administrator of Tyler County Hospital.

Commissioner Riley made a motion to modify the minutes of May 13, 1991(pg.3) to include that Donald Foster would be employed full-time after obtaining a physical examination at a salary equal to the salary being drawn by other courthouse staff comparable to that position. He further motioned the approval of the minutes of May 13, May 21, May 23 and June 3. The motion was seconded by Commissioner Mahan. All voted yes and none no.

A motion was made by Commissioner Mahan and seconded by Commissioner Sawyer that the monthly report of the Extension Department be approved as submitted. All voted yes and none no. SEE ATTACHED REPORT.

Commissioner Riley motioned to approve the County Treasurer's monthly report as submitted by Jean Phillips. The motion was seconded by Commissioner Sawyer. All voted yes and none no. SEE ATTACHED REPORT.

The approval of the monthly report of Wanda Brasher, J.P. #1 was deferred.

After review of the monthly report submitted by the County Auditor, a motion was made by Commissioner Mahan to approve same as submitted. This motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED STATEMENT OF CONDITION.

Commissioner Mahan made a motion to approve payment of the allowances and accounts payable, as submitted. Commissioner Sawyer seconded this motion. All voted yes and none no. SEE ATTACHED GENERAL LEDGER DISTRIBUTION REGISTER AND ACCOUNTS PAYABLE PAID.

After discussion of taking necessary action on the cancer policy, Judge Owens requested the County Treasurer follow up on any claims that may be outstanding. Commissioner Mahan suggested the policy be cancelled with the option that employees can continue to pay the premiums. Commissioner Riley motioned that action be tabled until Friday, June 14. Commissioner Sawyer seconded this motion. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to table opening bids on truck for Precinct #2 until Friday, June 14. All voted yes and none no.

The Tax Assessor-Collector presented solicited bids she received for a new typewriter. Commissioner Mahan motioned to accept the recommendation of Mrs. Tolbert to approve purchase of two new Royal typewriters for the tax office for a total of \$1050.00. These will be paid from courthouse equipment. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED BIDS.

Tom Stundivant presented the Hospital Budget for 1992. Projected total of capitol expenditures is \$167,100. The budget proposes a tax increase of 2.99% from \$.065 per \$100 to \$.0669. Mr. Stundivant correlated this increase toward the 58.4% increase in charity care. This report was received. No action was taken.

A motion was made by Commissioner Riley and seconded by Commissioner Mahan to appoint Jackie Getz to the Child Welfare Board. All voted yes and none no. SEE ATTACHED.

Elaine Clow presented a financial report and further stated that the bylaws of the **Child Welfare Board** needed to be changed in order that the fiscal year would coincide with the fiscal year of the County. **Commissioner Mahan** motioned that the Child Welfare Board change bylaws to correspond with the County from January 1 to January 1. The motion was seconded by **Commissioner Riley**. All voted yes and none no. **SEE ATTACHED REPORT & BYLAWS**.

Upon recommendation of Ms. Clow, Commissioner Mahan motioned and seconded by Commissioner Riley to grant permission to move their ending balance to an interest bearing account. All voted yes and none no. Ms. Clow discussed investing these funds with the County Funds for the highest interest rate.

Commissioner Riley motioned to approve payment of bills, submitted by Elaine Clow, subject to review by the County Auditor upon availability of funds. Commissioner Mahan second this motion. All voted yes and none no.

Further, Elaine Clow presented a projected increase in the their budget of up to \$42,000 for Foster Child Care. The Court directed that a budget request be presented giving an itemized explanation and proposal. SEE ATTACHED RATES.

Commissioner Riley motioned to approve the forfeiture budget as submitted by the Criminal District Attorney. Commissioner Sawyer seconded this motion. All voted yes and none no. SEE ATTACHED BUDGET.

A motion was made by Commissioner Sawyer and seconded by Commissioner Mahan to approve the line-item transfers to Road & Bridge 4, Data Processing and Juvenile Probation as submitted by the County Auditor.

A motion was made by Commissioner Mahan to approve payment to J.D. Taylor General Contractor, for construction work in the District Courtroom, as authorized by the District Clerk. Commissioner Sawyer seconded this motion. This will be paid from Capitol Improvements. All voted yes and none no. SEE ATTACHED PROPOSAL.

Commissioner Riley motioned to accept the monthly reports of the Probation Departments (Adult and Juvenile) as filed. This motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED REPORTS.
