A motion was made by Commissioner Riley and seconded by Commissioner Barnes to approve the minutes of July 8 and July 11, 1991. All voted yes and none no.

Commissioner Mahan made a motion to approve paying bills from the County Auditor's office as submitted and approve allowances and accounts payable from the Auditor's office. The motion was seconded by Commissioner Sawyer. All voted yes and none no with Commissioner Barnes abstaining from #015672 for Barnes Plumbing. SEE ATTACHED GENERAL LEDGER DISTRIBUTION REGISTER AND ACCOUNTS PAYABLE.

The only bid received was opened and read aloud concerning the cars for the Sheriff's Department. A motion was made by Commissioner Barnes to accept the bid from Knapp Ford Sales for two cars at \$14,530 each. The motion was seconded by Commissioner Riley. All voted yes and none no. SEE ATTACHED BID.

Bobbie Fields and Calvin Meyers, officers of the White Tail Ridge Volunteer Fire Department were present to speak for the petition to create a rural fire district within the White Tail Ridge Lake Estates subdivision. Judge Owens considered the petition to be in proper form and set a public hearing on October 7 at 1:00PM in the Commissioners' Courtroom. The County Clerk is to issue notices as required by law. Commissioner Barnes made the motion to accept the application for creation of Rural Fire Prevention District III. The motion was seconded by Commissioner Riley. All voted yes and none no. SEE ATTACHED PETITION.

Item #5 was deleted because of the Extension Department having no agent.

Commissioner Riley made the motion to approve the monthly report of the County Treasurer's office as submitted by Jean Phillips, County Treasurer. Commissioner Barnes seconded the motion. All voted yes and none no. SEE ATTACHED REPORT.

A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve the J.P. #1 monthly report as submitted by Wanda Brasher. All voted yes and none no. SEE ATTACHED REPORT.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to approve the line-item transfers from the departments of the Sheriff, District Clerk and Criminal District Attorney, as submitted from the County Auditor's office with the exception of transfers related to Constables for further clarification. All voted yes and none no. SEE ATTACHED LINE-ITEM TRANSFERS.

In discussion of the approval of funds for improvements in Room 103, Commissioner Mahan stated that he would pay for the radio out of his Road & Bridge as all radios had been paid for in the past. He then stated that the additional plumbing would be completed by courthouse employees or possibly Road & Bridge crews. He then asked for approval of \$941.13 for the following:
