the following were absent: Commissioner Riley thereby constituting a quorum. In addition to the above were:

Commissioner Barnes made a motion to approve paying bills from the County Auditor's office as submitted. The motion was seconded by Commissioner Sawyer. All voted yes and none no. SEE ATTACHED GENERAL LEDGER DISTRIBUTION.

A motion was made by Commissioner Sawyer and seconded by Commissioner Mahan to authorize going out for bids to sell a 1978 GMC truck from Precinct #4. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

Commissioner Mahan made the motion to accept the bid from Bryan and Bryan for the road oil and J.E. Gardner for gas, oil and grease and Matthews Construction for hot mix and cold mix and to reject any and all other bids. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED BIDS.

Jean Williams presented a proclamation concerning the Alabama-Coushata Indian Reservation. After it was read aloud, a motion was made by Commissioner Sawyer and seconded by Commissioner Mahan to adopt and sign the proclamation, resolving that Tyler County is designated as Indian Country in 1992 and urging citizens to attend the Spring opening. All voted yes and none no. SEE ATTACHED PROCLAMATION.

John Yearwood, Emergency Management Coordinator, presented recommendations concerning mapping and numbering county roads. stated that the roads have to be named and mapped to implement the 911 plan. Commissioner Mahan suggested measuring all county roads with lengths and distances included in the mapping. Barnhart, Postmaster from Woodville, explained the reason the roads need names instead of numbers. By 1995 the post office will be completely automated and everything will be run on machines and machines can tell a misspelled word but they cannot distinguish wrong numbers. This is trying to be done nationally not just Tyler County. Commissioner Mahan questioned as to what authority would the roads be named being public or private. Judge Owens conferred the authority would lie with the Emergency Management Coordinator and requested publicity as to the proposed names. After discussion, a motion was made by Commissioner Sawyer and seconded by Commissioner Barnes for the Emergency Management Coordinator to draw up grid maps with names of all roads and to bring back to Commissioners' Court for approval for 911 purposes. All voted yes and none no.

A mation was made by Commissioner Sawyer to adjourn and seconded by Commissioner Barnes. All voted yes and none no.
