Joyce Moore, County Auditor, told the Court that there had been twoproposals for the building insurance for the County. One proposal was from Texas Association of Counties and the other from Malcolm Collier. Mr. Collier stated that being a tax payer, he recommended the Association because it was a better deal. Commissioner Riley asked Mr. Collier to look over the Associations proposal. A motion was then made by Commissioner Riley to accept the proposal from the Texas Association of Counties for the county's building insurance and for Judge Owens to execute the Interlocal Participation Agreement, with the deductible of the insurance being \$1,000 with total cost of \$5,285 for coverage of all County buildings and contents. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED AGREEMENT.

Upon review and recommendation of Judge Owens as to amendments, Commissioner Riley made the motion to approve the Piney Woods Solid Waste Management Agency Interlocal Agreement with Judge Owens executing the agreement. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED

A motion was made by Commissioner Mahan and seconded by Commissioner Sawyer to approve the order ratifying and approving revisions to Piney Woods Solid Waste Management Agency Interlocal Agreement. All voted yes and none no. SEE ATTACHED ORDER.

Commissioner Riley made the motion to appoint Sandra Harrison to fill the unexpired term of Barbara Tolbert for Tyler County Tax Assessor Collector, effective April 1, 1992 at the salary of the Tax Assessor Collector. Commissioner Barnes seconded the motion. All voted yes and none no.

Upon recommendation of the engineer, a motion was made by Commissioner Riley to award the construction contract for the SHECO project to Oscar Crawford Construction for the Woodville waste water improvements in the amount of \$71,167.50 as per bid requirements, being a reputable and low bidder. Commissioner Sawyer seconded the motion. All voted yes and none no.

A motion was made by Commissioner Riley to adjourn and seconded by Commissioner Mahan. All voted yes and none no.
