Commissioner Mahan made a motion to amend the contract for compensation to a stockman to receive an amount of \$250 per month with \$100 per month for gas and the use of truck and trailer and other expenses, with no additional benefits; and, with the additional duties of being the animal control and trash violations officer with no benefits from the County. Violations will be turned over to a deputy for filing complaints. Commissioner Sawyer seconded the motion. All voted yes and none no.

A motion was made by Commissioner Riley to make available a benefit administered by the National Association of Counties for a deferred compensation plan at no cost to the County. Commissioner Sawyer seconded the motion. All voted yes and none no. SEE ATTACHED PLAN.
