A motion was made by Commissioner Riley to approve the commissioner's court minutes of March 17 and March 26, 1992. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

The County Auditor called attention to computer errors on pages 7 & 9 to Walmart. She also presented additional bills from R.E. Swearingen, MD and Turner Radiator. Further, Mrs. Moore presented a bill submitted by Commissioner Mahan to Service by Scott for water treatment system he wanted paid from General Fund. Commissioner Riley motioned to approve paying bills from the County Auditor's Office with the acceptions and corrections as noted by the County Auditor. Allen Sturrock with the Probation Department introduced Nancy Jones with MHMR to make a presentation to the Court. Ms. Jones presented a certificate of appreciation on behalf of the Board of Trustees to Jay Rabuck for his services for the past 6 years on the Public Responsibility Committee which is a rights protection group for the clients of MHMR services. She continued stating that during the past 6 years he had served on several investigative committees, investigating complaints and helped find solutions to the complaints and that he is only leaving because he has served the maximum allowable time that the rules permit. Rabuck stated to the Court that anyone who serves on a volunteer basis gets more out of his effort than whatever we are trying to serve and on behalf of all volunteers in Tyler County he would like to accept the certificate. Judge Sturrock added that MHMR is one of the strong organizations in East Texas and he appreciates the work Mr. Rabuck has done. He submitted an annual report. Judge Owens reiterated sentiments of appreciation for Mr. Raybuck as an outstanding representative.

Kenny Simpson, Adult Probation Officer, presented a Cooperative Agreement for substance abuse counseling.
