A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve the paying of bills. Commissioner Barnes abstained from Item #19177. All voted yes and none no. SEE ATTACHED GENERAL LEDGER.

The two bids received for the bank depository were opened and read. Community Bank declined to bid, leaving First National Bank of Jasper submitting the only bid by deadline. Commissioner Riley made a motion to table the bid for further study. Commissioner Barnes seconded the motion. All voted yes and none no. A bid was submitted by Citizens State Bank for the bank depository at 8:35 a.m. by Roy Bolding.

Commissioner Riley made the motion and it was seconded by Commissioner Barnes that Terry Riley be allowed to use up to \$1800 for improvements at the rodeo arena with approval of Matt Bochat, County Extension Agent. All voted yes and none no.

Commissioner Mahan discussed the county putting in septic systems at the arena area before Dogwood Festivities and the Rodeo. Also a permanent loading ramp and chute were discussed as being needed during the County Fair. This was not an agenda item; therefore, no action was taken.

A motion was made by Commissioner Riley that the meeting adjourn.
