Judge Owens was absent from this meeting due to the death of his father, Reverend J. P. Owens. An expression of sympathy was expressed by the Court for the Owens family.

Commissioner Riley made the motion to approve the minutes of the two December 21 Commissioners Court meetings held at 10:30 a.m. and 11:00 a.m. Commissioner Sawyer seconded the motion. All voted yes and none no.

Mr. John Rowe, Xerox representative, presented two proposals for a copier machine for the District Clerk's office. One proposal was for a lease; the other proposal was for a purchase. The price of the Xerox copier is \$12,030 less trade in of \$1,800 for a total price of \$10,230. A discussion on a Maintenance contract followed with Pat Brown recommending purchase of the maintenance contract. Commissioner Riley made the motion which was seconded by Commissioner Sawyer to buy the copy machine without Maintenance Agreement with the option to purchase contract within 90 days. Sheriff Hennigan presented a proposal concerning the release of bondsmen. He proposed having each bondsman sign an Affidavit which would place the expense needed, in apprehending a defendant, upon the bondsman. If the bondsman did not comply, then the bondsman would no longer be able to make bonds. Commissioner Riley made the motion to support the Sheriff in having each bondsman sign an Affidavit. Commissioner Barnes made the motion for Tyler County to hold an election and share in the cost with the Colmesneil I.S.D. on May 5, 1993. Commissioner Riley seconded the motion. All voted yes and none no. SEE ATTACHED AGREEMENT.
