COUNTY AUDITOR CRIMINAL DISTRICT ATTORNEY TAX ASSESSOR-COLLECTOR

Sandra Harrison, Tax Assessor Collector, made the court aware of her request for an updated system for the collection of taxes. She feels the need of reports and service is not being satisfied with her present software, also, reports as requested by members of the court she is unable to give using the present system. She introduced Leslie Silva, tax division manager, with Business Records Corp. to present the system available his company offers.

Mr. Silva proclaimed that the support of the system offered - he feels is a speciality of his department. He explained different options available. The production option includes the printing of the statements. The normal time of turn-around for printing normally does not exceed four days.

Commissioner Riley was concerned about proper training of the system.

Commissioner Mahan was interested in the conversion process of data from the Appraisal District to the Tax Office.

The price would depend on how much the tax office would prefer to do in-house.

If the tax office is added to the AS/400 housed in the courthouse, Mr. Silva committed to a cost waiver for the conversion of data from the System 36 to the AS/400 when the need arises. However, the transfer of files at the site would be based on \$70 p/hour if not provided by someone on staff at the County.

THE COURT TOOK A 10 MINUTE RECESS in order that the District Attorney could review the contract submitted by BRC.

COURT IN SESSION:

A motion was made by Commissioner Mahan to give the County Judge authority to negotiate a contract with agreement by the District Attorney. The motion was seconded by Commissioner Riley. All voted yes and none no.
