A motion was made by **Commissioner Barnes** to approve the minutes of April 16th, July 16th at 8:30 AM and July 26th at 9:00, 1993. **Commissioner Sawyer** seconded this motion. All voted yes and none no.

Commissioner Riley motioned to approve the County Treasurer's monthly report as submitted by Jean Phillips. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED REPORT.

A motion was made by Commissioner Riley to approve the monthly report of the Adult Probation and the Juvenile Probation Departments. The motion was seconded by Commissioner Mahan. All voted yes and fone no. SEE ATTACHED REPORTS.

Commissioner Riley made a motion to accept the monthly report of Wanda Brasher, J.P. #1 as submitted. The motion was seconded by Commissioner Barnes. All voted yes and none no. SEE ATTACHED REPORT.

A motion was made by Commissioner Mahan to approve the monthly reports of the County Extension Department. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

A motion was made by Commissioner Mahan to approve the monthly report of the County Auditor as submitted. The motion was seconded by Commissioner Riley. All voted yes and none no. SEE ATTACHED STATEMENT OF CONDITION.

Commissioner Mahan made the motion to approve the accounts payable from the County Auditor's Office as submitted, with exception to #28681 and #28704 being duplicated/billed twice and #28725 Pct#4 should be billed to airport. Commissioner Sawyer seconded the motion. All voted yes and none no. SEE ATTACHED ACCOUNTS PAYABLE PAID & GENERAL DISTRIBUTION LEDGER.

Kinney Simpson, Probation Supervisor, requested wiring for a telephone to the addition of the Probation Department. He presented options for the Court to consider. He also requested flooring for the two rooms. Judge Owens stated that until final decisions were made as to the allocation of space within the courthouse, he would rather not go into an expensive telephone system; therefore, he motioned for the approval of \$35.00 connection fee and the purchase of up to \$50.00 for a telephone; further to accept the proposal from Foster Carpets for carpeting two rooms, with reimbursement of one room to be paid from community service performance award grant funds. Commissioner Riley seconded this motion. All voted yes and none no. SEE ATTACHED REQUEST.

Commissioner Mahan motioned to appoint Beverly Perkins as Alternate Judge for Voting Precinct #9. Commissioner Riley seconded this motion. All voted yes and none no.

The Criminal District Attorney having no objections as to form, a motion was made by Commissioner Riley to authorize Judge Owens to execute a contract, on behalf of Tyler County, concerning the grant funding (\$250,000 grant award) for the sewer project. The environmental release will be signed this date, also. The motion was seconded by Commissioner Barnes. All voted yes and none no. David Waxman called attention to a mistake in the special conditions, (E) Section 22, will not be performing water system improvements.

After reading of the whole, Judge Owens presented a proclamation to Ken Bonds which urges Tyler County residents to support the new radio station, V-94 point 7 FM. SEE ATTACHED PROCLAMATION.

motion was made by Commissioner Barnes and seconded by Commissioner Sawyer approving an agreement with Champion International Corp. and Chester ISD for the delivery of sand. All voted yes and none no. SEE ATTACHED AGREEMENT.

The bids coming higher than anticipated, being \$190,000 instead of the projected \$130,000, a motion was made by Commissioner Barnes to authorize the execution of an amendment in order to proceed with the Airport renovation project. (TxDOT #93-34-063) The County share of this project is 10 percent. The motion was seconded by Commissioner Mahan. All voted yes and none no.

A motion was made by Commissioner Sawyer and seconded by Commissioner Riley to appoint Commissioner Jerry Mahan to the Tax Appraisal Board of Directors, due to the recent resignation of John Kinney. All voted yes and none no.

A motion was made by **Commissioner Riley** and seconded by **Commissioner Barnes** that the **County roads** be numbered and not named, superseding any action taken previously. All voted yes and none no.

Commissioner Riley called for the Court to consider the process as to which the roads will be numbered at the next meeting.

COURT RECESSED FOR 35 MINUTES AT 9:45 A.M. in order to await the arrival of Shawn Davis, representing Congressman Charles Wilson.

Commissioner Riley left the meeting and was unable to return.
