A motion was made by Commissioner Sawyer and seconded by Commissioner Riley to approve the minutes of August 9th at 10:00. All voted yes and none no.

Commissioner Mahan made a motion and it was seconded by Commissioner Riley to approve paying the bills and allowances as submitted by the County Auditor subject to confirmation of Account # 2345128 Reference # 26491 to Interstate Billing Service. All voted yes and none no. SEE/ATTACHED GENERAL LEDGER DISTRIBUTION.

Commissioner Mahan made the motion to reject all bids on the pull trailer for Pct. #3. This motion was seconded by Commissioner Riley. All voted yes and none no.

Wayne DuBose, 911 Coordinator with DETCOG, presented information concerning funding for numbering roads in the county. Application for the \$186,000 grant which has been allocated for Tyler County must be submitted before October 5. The County would be required to match 25% of the grant funding. Commissioner Sawyer suggests that roads be numbered to correspond with each precinct; Pct 1 would have roads with prefix of 100; Pct 2 would have roads with prefix of 200; Pct 3 would have roads with prefix of 300; and Pct 4 would have roads with prefix of 400. Commissioner Mahan suggested that the County re-district before numbering roads. Commissioner Sawyer made the motion which was seconded by Commissioner Riley to proceed with numbering the roads based on the precinct number. All voted yes and none no.

Commissioner Riley made a motion to remove the presentation by Startel, long distance service, from the agenda due to the fact that Pat Young Bordenkircher was not present. Commissioner Mahan seconded the motion. All voted yes and none no.

A motion was made by Commissioner Sawyer that the meeting adjourn.
