A motion was made by Commissioner Riley and seconded by Commissioner Nahan to approve the minutes of August 30th at 8:30, August 30th at 9:00 AM and September 13, 1993. All voted yes and none no.

The Court heard an explanation from Sheriff Hennigan concerning a bill from the stockman that will be reimbursed by the buyer or owner. The County Auditor called attention to a bill from Deep East Texas Self Insurance Fund (Worker's Compensation) in the amount of \$10,137.83, being an adjustment of estimated amount due from an audit o. files. Commissioner Riley motioned to table approval of the bill from Deep East Texas Worker's Compensation for further study and clarification; and, to approve payment of all other bills submitted by the County Auditor including the bill from the stockman. The motion was seconded by Commissioner Mahan. All voted yes with exception of Commissioner Barnes abstaining from item to Barnes Plambing. SEE ATTACHED GENERAL LEDGER DISTRIBUTION.

A motion was made by Commissioner Barnes to table opening and considering bids for office space for the Attorney General until /September 30, 1993, due to notice to bidders not being printed in newspaper for a second week. Commissioner Riley seconded the motion. All voted yes and none no.

Sherry Jeanes requested a new copy machine for the Extension Department. She justified her request giving the age of the machine, cost of service and repairs, office unattended using other copiers, etc. A motion was made by Commissioner Riley and seconded by Commissioner Mahan to table consideration of this request for further study as to a source of funding and coordinating the use with the juvenile probation department. All voted yes and none no.

Judge Owens recapped the process of departmental hearings, posting of required notices and public hearing for adopting a tax rate. Upon reading of the whole, a motion was made by Commissioner Mahan and seconded by Commissioner Riley to adopt the ordinance setting forth the tax rate of .095¢ for the tax year of 1993 for the Tyler County Hospital. All four members voted yes. Commissioner Sawyer was absent. SEE ATTACHED ORDINANCE.

A motion was made by Commissioner Barnes and seconded by Commissioner Mahan to adopt the ordinance setting forth the tax rate for Tyler County for the 1993 tax year, being a total of .56¢. All members of the court present voted yes. SEE ATTACHED ORDINANCE.
