A motion was made by Commissioner Riley to approve the minutes of September 13th at 10:00AN and 11:00 AN and September 17th. The motion was seconded by Commissioner Nahan. All voted yes and none no.

Consideration and approval for Tyler County Rural Addressing System with DETCOG died for lack of a motion.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to approve the bond of Henry Earl Sawyer, Jr. as Treasurer for Rural Fire Prevention District #1. All voted yes and none no with Commissioner Sawyer abstaining. SEE ATTACHED BOND.

The need for a consistent policy concerning the signs posted at corner of the courthouse was discussed. It was the consensus that the posting be limited to non-profit or charitable organizations. motion was made by Commissioner Riley to leave Pat Brown, District Clerk as the designated officer; adding that she consult with the County Attorney and County Judge to draft policies to be approved by the Court. The motion was seconded by Commissioner Sawyer. All voted yes and none no.
