Marion Tidwell, Lee Brown and Truit Williams were present to request the Court to purchase a van to be used by the Tyler County Nutrition Center for the delivery of meals. Mrs. Tidwell reported that the Board had been enlightened to the fact that the van received through State funding could be used for transportation of people only.

Members of the Board answered questions of concern from Commissioner Mahan appertaining to number of meals delivered in other areas of the County; present funding from the County in the amount of \$18,000; and, whether there is a need for an additional vehicle with the federally assisted transportation system that will be coming to Tyler County.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to authorize the purchase of a van as requested by the Board on Aging, from Larry Trest Auto in the amount of \$10,695.00. The Nutrition Center will reimburse the County for all cost of the purchase and monthly insurance premiums. All voted yes and none no.

Judge Owens commended the Board on improvements that had been made. Adding that this center is the best in all ares of operation in the 12 county area.

A motion was made by Commissioner Barnes and seconded by Commissioner Mahan that the meeting adjourn.
