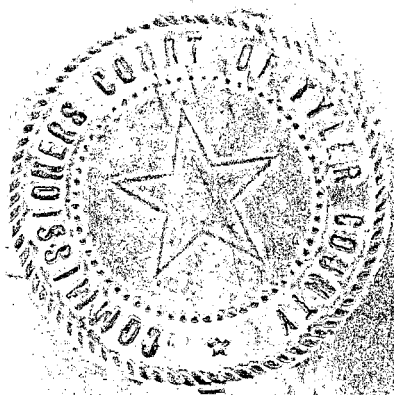

- * Cutting width shall be 50" of actual cut.
- * Cutting head shall be industrial strength.
- * Cutting head shall have full length replaceable skid shoes on inner and outer ends.
- * Cutting assembly shall be rotary, hydraulically driven.
- * Cutting assembly shall be attached to the spindle by six minimum of 5/8" grade eight bolts with tapered bolt protector.
- * Minimum spindle speed is 1,750 RPM.

- ENGINE:** Shall be a 4 Cylinder, direct injection diesel engine of at least 268 cubic inch displacement and have a SAE horsepower rating of 102 engine horsepower and 86 PTO horsepower at 2,100 RPM. The engine will be valve in head, 4 cycle and be equipped with electric start, cold weather starting aid, and full flow oil filter. Engine shall be Turbo-Charged.
- UNIT TYPE:** Shall be wide front utility type (not low slung industrial or high clearance row crop agricultural).
- TRANSMISSION:** Shall be constant mesh, with a minimum of 8 speeds forward and 2 reverse.
