A motion was made by **Commissioner Sawyer** to approve the minutes of April 11, 1994. The motion was seconded by **Commissioner Mahan**. All voted yes and none no.

Commissioner Sawyer requested that #5142 be removed from Precinct #4 and charged to landfill. A motion was made by Commissioner Riley and seconded by Commissioner Mahan to approve payment of bills submitted by the County Auditor, with exception to #36483 to hold until Auditor receives proper documentation before payment. All voted yes and none no with exception of Commissioner Barnes abstaining from #36418. SEE ATTACHED DISTRIBUTION LEDGER.

Commissioner Riley motioned to appoint Tina Bump to fill the unexpired term of County Treasurer, Jean Phillips, to be effective May 1, 1994 and authorize Mrs. Bump to sign all matters relating to the office of County Treasurer, including financial matters and the Texas County and District Retirement System. Commissioner Barnes seconded the motion. All voted yes and none no. Mrs. Bump informed the Court that the swearing-in ceremony would be Friday, April 29th. Judge Owens recommended that the official swearing should take place after May 1st. Tina Bump thanked each member of the Court individually with a hand shake.

Randy Blanks updated the Court that each home owner, as of now, would have to pay the permit fee ranging from \$110 to \$260 for **septic systems**. Mr. Blanks clarified the fees would be deducted from the grant leaving less funds and fewer septic systems. He requested the Court ask for waivers by the State. A motion was made by **Commissioner Mahan** to adopt a resolution requesting waiver of permit fees for on-site sewage facilities being constructed with **Texas Community Development Funds**. **Commissioner Riley** seconded the motion. All voted yes and none no. SEE ATTACHED RESOLUTIONS.

Richard Foxworth, Warren, called for clarification as to the fees

charge at the collection center. Commissioner Sawyer responded that he had contacted Warren ISD and they would be paying for dumping fees. Commissioner Riley and Judge Owens refuted to Mr. Foxworth that he had made a profit off of dumping and the County had always lost money. Other answers included if the County continued to loose money on the garbage dumping there would be less funds for other services to the citizens; that, it was more fair that every citizen pay for disposal and not just taxpayers; that, commercial haulers were getting a reduction by paying per cubic yard than by the bag.

The Court also heard complaints from:

Joyce Clemments, Warren - she and her husband were not able to travel to the collection center.

Ruth Winters - requested the County to furnish trash pick-ups for shut-ins.

Herbert Morrell - garbage being dumped in ditches and he was getting no results, though he brought forth names.

Weslie Harrison, Warren - in favor in assistant to the elderly who can't travel to the collection center.

Members of the court responded, as questioned, that because of an agreement the prison system was allowed to dump garbage for five years from the time of construction; that, Tyler County has had agreements with the State Highway Department for dumping. Also, they were not aware of an agreement that Warren ISD dump free of charges. Judge Owens concluded regretfully that the County could not meet every need and could not raise enough taxes to meet every need. He encourage neighbors to help fellow neighbors who are unable to travel to the collection center to dump their garbage.

A motion was made by Commissioner Riley that the meeting adjourn.
