The invocation was delivered by Steven Odom, a student at A&M University.

Commissioner Mahan motioned to approve the minutes of February 17, 1995. The motion was seconded by Commissioner Riley. All voted yes and none no.

County Auditor, Joyce Moore, opened and read aloud the bids received for a 3/4 ton pickup truck for Precinct #2. Commissioner Barnes requested deferral of a decision to later within this meeting.

A motion was made by Commissioner Sawyer to authorize advertisement for bids to sell scrap iron, a used dump truck and dump truck bed from Precinct #4 with stipulation that the scrap iron be removed within 45 days from bid. Commissioner Mahan seconded the motion. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

Commissioner Riley motioned to approve the line-item transfers, presented by the County Auditor, for the Jury Account, Road & Bridge #1, Road & Bridge #3 and change Cont. Part-time Salaries to Cont. A motion was made by Commissioner Riley to award the bid for a backhoe for Precinct #1 to East Texas Machinery being the lowest bid that met all specifications. He stipulated the machinery be delivered within 30 days or the bid be rejected. Commissioner Mahan seconded the motion. All voted yes and none no. SEE ATTACHED BID.

Commissioner Mahan motioned to reject all bids for a pick-up truck and pup trailer for Precinct #3 in order to rebid with advertisement for issuance of time warrants. Commissioner Riley seconded this motion. All voted yes and none no. SEE ATTACHED BIDS.

The County Auditor requested bills be approved with addition of those from Tyler County Tractor and Mustang Tractor, waiting on invoices. A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve payment of the bills as submitted the by the County Auditor.
