Commissioner Sawyer motioned to approve the minutes of May 8, 1995. The motion was seconded by Commissioner Barnes. All voted yes and none no.

The County Auditor requested bills be approved with addition of those from Walmart and Medicine Shoppe, waiting on invoices. A motion was made by Commissioner Barnes and seconded by Commissioner Sawyer to take the recommendation of Jeff McRae with the delinquent tax attorney firm concerning trust property, accepting the bid from Patricia Brown on 4.0179 acres in the J.
