The County Judge was presiding over a probate matter at the beginning of this meeting; therefore, Commissioner Mahan presided until his appearance.

Commissioner Riley motioned to approve the minutes of June 12, 1995. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve payment of the bills as submitted by the County Commissioner Barnes abstained from discussion and voting on Items relating to Barnes Plumbing, #54492. All others voted yes and SEE ATTACHED GENERAL DISTRIBUTION LEDGER. none no.

The County Auditor opened the bids on used vehicles from the sheriff's department. Bids were received from Mr. Calhoun, Lade Sales, Bill Shaw, Knapp Ford, Marell Auctions(LA) and Winters Motor Corp. (NY) A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to accept the high bids being:

## JUDGE OWENS PRESIDING:

Upon recommendation of the County Judge, using a nomination from the local Bar Association, a motion was made by Commissioner Mahan and seconded by Commissioner Barnes to appoint a Law Library Committee consisting of Judge Owens, James A. Clark (District Attorney) and This committee will maintain the library and assure Earnie Gassiott. that funds are appropriated properly. All voted yes and none no.

Judge Owens commended Commissioner Barnes on his supervision of maintenance at the rodeo arena/fair grounds and the success of Commissioner Riley in obtaining funds for the renovation of the restrooms at the fair grounds. Commissioner Riley introduced those responding with donations:

Commissioner Riley and Treasurer, Tina Bump presented the changes to the County Policy for employees. Policies were added and/or changed for sexual harassment, Family Medical Leave Act, nepotism, applications for employment and performance reviews. Also, added to the manual was the previous action taken on political activity. Commissioner Riley motioned, with a second by Commissioner Mahan, to adopt the policies as presented. All voted yes and none no.

David Waxman made the Court aware of the process and the need of a committee to review proposals concerning the project for the Cypress Creek Water Supply Corp. Judge Owens named a committee of Lloyd Fortenberry, Guy LaFoy and Commissioner Riley. Mr. Waxman indicated the scope of work for upgrading the system would be a proposed new water well/filter to remove iron/forced dry aerator/various valves. He opened proposals received from:

One bid was received after the deadline and was not opened. A motion was made by **Commissioner Riley** and seconded by **Commissioner Sawyer** to appoint the committee as named by Judge Owens to review the proposals received by the deadline, and return with a recommendation. All voted yes and none no.

A motion was made by Commissioner Riley to authorize an auction on July 6, 1995 for four vehicles which had been seized and forfeited by the sheriff's department. Commissioner Mahan seconded the motion. All voted yes and none no. SEE ATTACHED NOTICE.

A motion was made by Commissioner Mahan and seconded by Commissioner Sawyer to table consideration of a resolution for improvements at the Tyler County Airport until ready for review. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Barnes to approve the Juvenile Probation monthly report. All voted yes and none no. SEE ATTACHED REPORT.

David Davis requested the Court to consider improvements to the Girls Ball Park for parking and practice fields. A motion was made by Commissioner Sawyer and seconded by Commissioner Riley that Commissioner Barnes and Mr. Davis study the feasibility of cutting the timber and having the area surveyed and return a recommendation to the Court. All voted yes and none no.

Commissioner Mahan motioned the meeting adjourned.
