A motion was made by **Commissioner Sawyer** and seconded by **Commissioner Riley** to approve the minutes of October 16th, 20th and October 24th; November 3rd at 9:00AM and 9:30AM. All voted yes and none no.

Commissioner Riley motioned to approve the monthly reports of October and November of the County Treasurer. Commissioner Barnes seconded the motion. All voted yes and none no. SEE ATTACHED REPORTS.

Commissioner Mahan motioned to approve the monthly reports of the **Adult and Juvenile Probation Departments.** The motion was seconded by **Commissioner Sawyer.** All voted yes and none no. SEE ATTACHED REPORTS.

Commissioner Mahan motioned to table the monthly reports for the Justice of the Peace, Pct. #1, due to illness. The motion was seconded by Commissioner Barnes. All voted yes and none no.

A motion was made by **Commissioner Sawyer** to approve the **monthly reports** of the **County Extension Department**. **Commissioner Mahan** seconded the motion. All voted yes and none no. SEE ATTACHED REPORTS.

Commissioner Riley motioned to approve the monthly report of the County Auditor. Commissioner Barnes seconded the motion. All voted yes and none no. SEE ATTACHED STATEMENT OF CONDITION.

Commissioner Riley announced he would be abstaining from vote on item #37723(Riley Funeral Home) in the amount of \$48.03 and further motioned to approve the accounts payable from the County Auditor's office, as submitted. Tina Bump reported the changes made to the policy as submitted by the airport committee, as discussed in the previous meeting. The committee recommended proof of liability insurance be required.

Commissioner Riley strongly agreed. The Court recommended the addition of default provisions. A separation of rental fees and taxes needed to be clarified. Judge Owens instructed that notices of the proposed policy be mailed to owners and renters for their comments before adoption by the Court. Commissioner Mahan suggested a provision for the hangers to be inspected by a County representative. A motion was made by **Commissioner Mahan** and seconded by **Commissioner Riley** to table action on the policy until Friday, December 15th, as requested by Mrs. Bump. All voted yes and none no. SEE ATTACHED. Ron Carpenter gave a brief update of the **911 addressing project**. A motion was made by **Commissioner Riley** and seconded by **Commissioner Mahan** to accept the report. All voted yes and none no.

Commissioner Riley motioned to approve the prisoner custody agreement. Commissioner Barnes seconded the motion. All voted yes and none no. SEE ATTACHED AGREEMENT.

A motion was made by **Commissioner Riley** to grant a 15 foot **easement** to the **City of Woodville** on property at the Tax Office and that of the Tyler County Hospital (if not already deeded to the hospital); and, that Judge Owens be authorized to execute such easements. The motion was seconded by **Commissioner Mahan**. All voted yes and none no. SEE ATTACHED EASEMENTS. The easements will be used to upgrade **sewage lines** down 190 West.

Commissioner Riley motioned to approve the rider to **bond** of Louise Breaux for Judy Whitehead in the County Treasurer's office. The motion was seconded by **Commissioner Mahan**. All voted yes and none no. SEE ATTACHED.

A motion was made by Commissioner Mahan and seconded by Commissioner Barnes to approve the bond of Eddie Norton, Rural Fire Prevention District #4, at no expense to the County. All voted yes and none no. SEE ATTACHED BOND.
