Randy Blanks presented a proposal for an application to the Texas Department of Transportation for grant funds for a Tourist Center and pavilion at the fair grounds. He noted that if the Court chose to include a hike and bike trail, continuing the one being constructed by the City of Woodville, the application could receive a higher priority. Commissioner Riley was concerned as to the cost of maintenance and policing such a trail. A motion was made by Commissioner Riley to adopt a resolution authorizing the submission of an application for the grant funds with a deletion of the hike and bike trail. The motion was seconded by Commissioner Sawyer. All voted yes and none no. SEE ATTACHED RESOLUTION.

Don Shaw, manager for the City of Woodville, presented a resolution which calls for support of enhancement funding for the hike and bike trail in the City of Woodville. Commissioner Riley motioned to adopt the resolution endorsing the nomination by the City of Woodville for their hike and bike trail project. Commissioner Mahan seconded the motion.
