A motion was made by Commissioner Sawyer and seconded by Commissioner Mahan to approve the minutes of June 10, 1996. All voted yes and none no.

The County Auditor presented correction on Pg 7 #71725 should reflect She presented a bill from PBX for fees (\$3,476.10) to find overcharges by AT&T which was supposed to come out of a refund. refund from AT&T went for a new phone system in the District Clerk's department instead of remitting to the County (\$5,793.50). The District Clerk was unaware of a contract with PBX for a refund. Commissioner Riley was concerned the contract had not been approved through the commissioners court. A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve payment of the bills as submitted by the County Auditor, with addition of Colliers Insurance for liability insurance for the County Clerk and the bill The bill from PBX will be taken from Courthouse Repairs SEE ATTACHED GENERAL All others voted yes and none no. budget. DISTRIBUTION LEDGER.

Commissioner Barnes motioned to table consideration of conditions at the **Tyler County Airport**. Commissioner Mahan seconded the motion. All voted yes and none no.

Commissioner Riley counted it a privilege to re-appoint Judge Allen Sturrock for a two year term to the board of trustees of the Burke Center. A seconded was received by all other commissioners. Unanimously carried. Later in the meeting Judge Sturrock arrived and voiced his appreciation of the support.

Cary Sims presented the rules for the County Fair Ground fees. The changes include clauses that all events must be sponsored by a Tyler County resident; Lions Club rodeo was deleted; officers and employees of Tyler County and Commissioners Court was added to item #3; groups will be responsible for liability insurance and must show proof; \$50 fee to non-profit groups and \$100 fee for lighted events. A motion was made by Commissioner Riley and seconded by Commissioner Mahan to adopt the rules as presented. All voted yes and none no. SEE ATTACHED.

Lloyd Fortenberry presented a proposal to take .099 of an acre on the "Old Livingston Highway" for a pump station location for Cypress Creek Water Supply. Commissioner Riley motioned to grant this acreage to Cypress Creek Water Supply and further authorize Judge Owens to execute the deed. The motion was seconded by Commissioner Mahan. All voted yes and none no. Cypress Creek Supply will have the deed prepared.

Judge Owens gave general report of the status of UTMB health care in Tyler County. They had received a grant that would take care of them financially for one more year. He encouraged citizens to lobby the legislators for funding of UTMB for indigent health care.
