A motion was made by Commissioner Mahan and seconded by Commissioner Barnes to table approval of the monthly report of the County Auditor, until Friday, September 13th. All voted yes and none no. The meeting was adjourned by motion from Commissioner Riley.

(no relation to Commissioner Riley). He further reported the Water Supply Board was in concurrence with the recommendation. Further, a change order will be negotiated to reduce the bid by \$15,000 to bring within the budget. Commissioner Riley motioned to award the project to Riley Construction Co., at no cost to the County. Commissioner Mahan seconded the motion. All voted yes and none no.

The County Treasurer introduced a proposal for supplemental benefits and cafeteria plan from American Capitol Enterprises, since she was dissatisfied with the service from AFLAC as to IRS reports. After questions as to the proposal presented by Mr. Sprang, Commissioner Riley motioned to table this matter to Friday, September 13th for comparison to the present plan.
