The County Auditor and County Treasurer presented salary schedules A motion was made by Commissioner Sawyer to approve the salary schedules as agreed upon in budget workshops. Commissioner Marshall seconded the motion. All voted yes and none no.

The Auditor and Treasurer left the meeting.

Kenneth Brooks from the Texas Department of Transportation presented a list of 5 bridges that were approved in 1995 to begin construction in August 1998: 1) Turkey Creek - 526-001 - Precinct #1
2) Beel Branch - 230-001 - Precinct #3

- 3) Caney Creek 126-001 Precinct #2(needs order)
- 4) Little Cypress Creek 531-001 Precinct #1
- 5) John Gore Loop 277-001 Precinct #4

It was pointed out the last page of the agreement shows the payment schedules: 1st payment 30 days after signing agreement; 2nd and final payment due 45 days prior to letting contracts. Bids will be let early 1998.

To upgrade or change priority of bridges will take a letter from the commissioner. Category 2 with ratings of 69 or above can be upgraded.

These bridges were also reviewed:

- 8) Co. Rd. 176 Precinct #1 & #4 bridge two years old; re-done but leave on list
- 9) Beech Creek Precinct #4 next one
- 10) Drake Branch Precinct #4 pilings re-done 3 years ago
- 11) Sugar Creek Precinct #3 Next
- 12) Springhill Turkey Creek
- CATAGORY 2: 13) FM 256 Billum Creek CR109 leave it on list; need to find correct bridge
 - 14) Springhill Rd Precinct #1 needs to be upgraded to Category 1
 - 15) East of FM92 no longer exists
 - 16) Magnus Creek/Mill Creek needs to be upgraded to Category 1
 - 17) Campbell Creek Precinct #1 delete; all metal bridge
 - 18) FM1014 Rockland Precinct #3 leave on list
 - 19) Pedigo Rd off 92 Precinct #3

In summary, numbers 6,9,10,11 & 12 will be next letting for construction; numbers 13,14,15 & 16 to be upgraded to CATEGORY 1; number 17 deleted. Bridges to be monitored are numbers 18, 19 and 20.

Commissioner Barnes motioned to accept the off-system bridges as presented and changes made in summarization; authorize the upgrade of Caney Creek bridge, along with those listed as numbers 13,14,15 & 16; authorize County Judge to execute documents necessary to proceed with the five ready for construction and to execute documents necessary to request upgrading of categories. Commissioner Sawyer seconded the motion. All voted yes and none no. SEE ATTACHED.
