Leslie Waxman presented a resolution concerning the 1996 Disaster Relief Project - Ivanhoe. Commissioner Riley motioned to adopt the resolution concerning authorized signatures. Commissioner Marshall seconded the motion. All voted yes and none no. SEE ATTACHED RESOLUTION.

Walt Davis presented a request from the Woodville Housing Authority for a waiver for payment in lieu of taxes. \$4000 is owed to the County for tax years 1993,1994 and 1996. Judge Owens recommended this request be presented through Sandra Crittenden to the delinquent tax firm. He stated that it was the policy of the County to channel questions concerning taxes through the attorney for delinquent taxes for study of the rules and proper legal action to be taken. Commissioner Riley motioned to table this request for an opinion as the the proper action. The motion was seconded by Commissioner Sawyer. All voted yes and none no.

Sheriff Hennigan requested approval for sheriff's department officers to run security surveillance for the U.S. Corp of Engineers during the summer months. The Corp of Engineers would pay \$13.81 per hour to the officer and pay 30 cents per mile to the County for use of the vehicles on a one year contract. Commissioner Marshall was concerned the money would be deposited into the sheriff's budget and not that of the general fund. Commissioner Riley suggested the use of vehicles being bidded off verses the wear and tear on new patrol cars. A motion was made by Commissioner Marshall and seconded by Commissioner Sawyer to table this matter until Friday, March 14th for further study. All voted yes and none no.

Sheriff Hennigan made the court aware he has 22 federal prisoners and had to take three patrol cars for transporting. As requested by Sheriff Hennigan, Commissioner Riley motioned to authorize advertisement for bids for a van for transporting purposes. The bids will be opened April 14th at 10:00. Commissioner Barnes seconded the motion. All voted yes and none no. SEE ATTACHED NOTICE.

Sheriff Hennigan presented a county curfew similar to that of Williamson County. It would concern children 16 years old and down. The curfew would be during school hours and after 12 midnight. He reported all superintendents of schools were in favor of the curfew. This matter will be studied further. No action was taken.

A motion was made by Commissioner Riley and seconded by Commissioner Marshall to approve the lease of a copy machine for the Justice Center to be within the sheriff's budget. All voted yes and none no.
