Tony Douglas presented Matt McCorver as a prospective County Agent. He spoke of Mr. McCorver's qualifications. He would be available to start work January 15th. Commissioner Riley stressed the County Fair and 4-H programs were very important to this county. **Commissioner** Riley motioned to hire Matt McCorver as the County Extension Agent. The motion was seconded by Commissioner Barnes. All voted yes and none no.

A representative from the Texas Department of Transportation requested the county assist with the purchase of right-of-way to correct a slope failure on the property of Mr. Deppe. He estimated the cost at 10% of \$60,000. Commissioner Riley inquired about several projects. Judge Owens and Commissioner Marshall inquired as to the status for right of way for the Hwy 92 project. Commissioner Marshall stated that he preferred the 92 right-of-way be purchased before this slope project. He reluctantly motioned to authorize up to 10% - \$6000 for the purchase of right of way for the Deppe project. Commissioner Riley seconded the motion. All voted yes and none no...

A motion was made by Commissioner Riley and seconded by Commissioner Sawyer to approve \$6700 to the transferred to the County Court Budget. All voted yes and none no. SEE ATTACHED.
