department and County Clerk. Commissioner Riley reported that
District Court had been temporarily moved to the Justice Center.

Commissioner Riley motioned to suspend the bidding procedures; and to
approve a contract for a turn-key job for cleanup and repairs to
restore the offices; and, authorize the County Judge to execute such
contract from C & B Services, which will also take the damaged
equipment to be cleaned and refurbished, with a stipulation that
C & B execute a performance bond in the amount of \$15,000 payable to
Tyler County. Commissioner Marshall seconded the motion. All voted
