A motion was made by Commissioner Sawyer and seconded by Commissioner Marshall

Commissioners' Court Minutes

July 12, 1999

Commissioner Riley motioned to approve **paying the allowances and accounts payable** as submitted by the **County Auditor**. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED GENERAL LEDGER DISTRIBUTION REGISTER.

Commissioner Marshall motioned to approve the **Airport Lease Agreements** between Tyler County and M.K. Stephenson, Floyd Lanclos, George Huckins, Jr., James H. Harris, Gerald Delaney and Larry S. Havard at \$25 with exception that if the hangers are used for commercial purposes the fee would be \$125, to become effect in August 1999.

Commissioner Hughes seconded the motion. All voted yes and none no.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Hughes** to table approval of Hap Champagne to the Fire District Board until Friday, July 16th. All voted yes and none no.

Jackie Cowart presented a **petition** of 574 signatures requesting assistance for a stop light both ways or a red light at the intersection of Hwy 92 and Hwy 190. Mrs. Cowart's complaint was that there had been many tragic accidents and that the present safety signs and lights were not enforced. Commissioner Riley suggested the Court write a letter to the TXDOT for assistance; and, the Court will talk with the State Troopers for ticketing violations. **Commissioner Marshall** motioned that a letter be written to TXDOT as to these hazards in both the Dam B area and Hilltop area in Colmesneil in **Precinct #3**.

Commissioner Riley seconded the motion. All voted yes and none no.

A motion was made by **Commissioner Riley** and seconded by **Commissioner Marshall** to accept 0.2 mile extension to the **County Road 1052**. Commissioner Riley had indicated that it met the specifications for acceptance. All voted yes and none no.

Judge Owens presented the qualification statements from architectural firms for a plan for **courthouse restoration**. A motion was made by **Commissioner Riley** to table approval until Friday, July 16th, for further study. **Commissioner Marshall** seconded the motion. All voted yes and none no. Statements were received from Ray Bailey Architects, Inc., Graham B. Luhn and David Watson.
