
Sheriff Hennigan presented a **grant** application that will be due Friday, March 30<sup>th</sup> to

would be 10% (\$845) to which Sheriff Hennigan offered from his budget.


**Commissioner Marshall** motioned to adopt the resolution authorizing the grant

ATTACHED RESOLUTION.


Commissioner Marshall motioned the meeting adjourned.




WHEREAS, Tyler County Commissioners Court has agreed to provide matching moneys for the said project in the amount of \$845.00; and
