A motion was made by Commissioner Marshall and seconded by Commissioner Woodrome to approve the minutes of July 6th. All voted yes and none no.

A motion was made by **Commissioner Hughes** to approve paying the **bills**. The motion was seconded by **Commissioner Marshall**. All voted yes and none no. SEE ATTACHED.

Commissioner Marshall motioned to approve the line item transfer for the **County Extension Department**, as submitted by the **County Auditor**. **Commissioner Woodrome** seconded the motion. All voted yes and none no. SEE ATTACHED LINE ITEM TRANSFER

Commissioner Woodrome motioned to award the following bids for **road materials**:

Wilson Culverts - Galvanized Culverts
Lumberton Culverts - Plastic Culverts
Bayou Forest Products, Sulphur LA - Bridge Materials
Lacy, San Augustine - blue rock
Matthews Construction - Oil & Sand, Hot Mix/Cold Mix

STIPULATIONS: Commissioner Marshall stated that G&W was installing a rock crusher and would have rock that could be obtained locally. Commissioner Walston wanted to continue to purchase slag from a business in ~~Jefferson~~ ^{Orange} County, due to its location was cheaper for precinct #4. Commissioner Marshall seconded the motion. All voted yes and none no.

Commissioner Walston reported that the agricultural building at Spurger ISD has now been rebuilt and advised that the **polling place for Box #14** should be returned to that original place for voting in county and state held elections. Donece Gregory agreed that it would be less

confusing for voters having it at the same place as school elections. A motion was made by Commissioner Woodrome to move the polling place from the Masonic Lodge in Spurger back to the agricultural building of Spurger ISD, pending approval by the Justice Department in Washington. Commissioner Marshall seconded the motion.

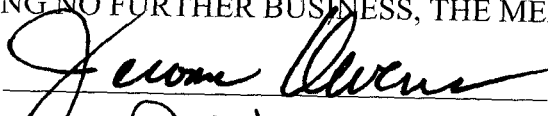
Don Head presented comments concerning road designation on Woodland Ave. in **Head Acres subdivision** within commissioner precinct #3. He stated there had been a conflict with the plat. The original plat was dated 1946 had 60' right of way for the road. He requested the present county road be continued from Woodland Ave. to Cottonwood Street. There presently exists possible encroachment by some landowners. Commissioner Marshall stated the road in question is not a county road but is designated a public road by the filing of the plat. The 911 program has only two designations for signage – county roads or private roads. Judge Owens and Commissioner Marshall indicated this matter between neighbors would need to be resolved in a civil action and not of the jurisdiction of the commissioner's court. No action was taken.

Judge Owens introduced representatives from POST (Partnership of South Texas). Steve Boozer described a directory whereby they wanted to include every type of service to government entities including caterers, photographers, etc. He invited the court to participate in "Big 9 – Big Day" for all counties and vendors in this region. He also alluded information about the South Texas Workforce Network. Not an agenda item-no action taken.

A motion was made by Commissioner Marshall for the meeting to adjourn.

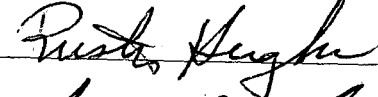

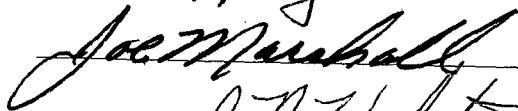

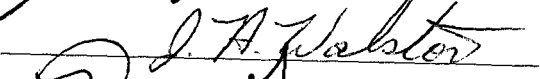
C.D. Woodrome, Comm. Pct. #1



Rusty Hughes, Comm. Pct. #2

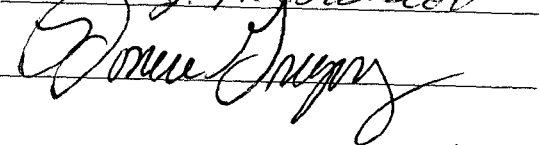


Joe Marshall, Comm. Pct. #3

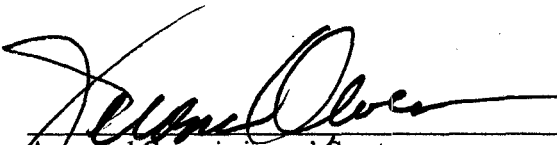
