ORDER PROHIBITING CERTAIN FIREWORKS IN UNINCORPORATED AREAS OF TYLER COUNTY, TEXAS

WHEREAS, the Texas Forest Service has determined that drought conditions exist in Tyler County; and

WHEREAS, on the 9th day of June, 2003, the Commissioners' Court of Tyler County has determined that the normal dangers of fire in the unincorporated areas of Tyler County is greatly enhanced by the extremely dry conditions now existing;

NOW, THEREFORE, the Commissioners' Court of Tyler County adopts this Order prohibiting the sale or use of restricted fireworks in the unincorporated areas of Tyler County.

- A. No person may sell, detonate, ignite or in any way use fireworks classified under 49 C.F.R. part. 173.100(R)(2) (10-1-86 edition), as "skyrockets with sticks" and "missiles with fins" in any portion of the unincorporated are of Tyler County.
- B. This Order does not prohibit:
 - 1. common fireworks, small in size, classified as Class C explosives;
 - 2. large fireworks devices designed primarily to produce visible or audible effects by combustion, deflagration, or detonation and classified as Class B explosive by the U. S. Dept. of Trans. [TEX. OCC. CODE, Chapter 2154]; and
 - 3. fireworks display where the fire truck is at the site.
- C. A person commits an offense if the person knowingly or intentionally violates a prohibition established by this Order. An offense under this Order is a Class C Misdemeanor.
