The invocation was delivered by Judge Blanchette.

A motion was made by Commissioner Walston and seconded by Commissioner Marshall
to table approval the minutes of three meetings: January 12, 25th and February 12th. All
voted yes and none no.

Commissioner Hughes motioned to approve paying the **bills** presented by the **County
Auditor**. **Commissioner Marshall** seconded the motion. All voted yes and none no.

A motion was made by **Commissioner Hughes** and seconded by **Commissioner
Marshall** to approve **line item transfers** for **Road and Bridge Precinct #2 and
Precinct #3**. This was to adjust the "carry over" from 2006. All voted yes and none no.
SEE ATTACHED LINE ITEM TRANSFERS.

The County Auditor stated item #4- concerning budget amendments was a duplication of
the above action. No action was taken on item #4 of the agenda.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner
Walston** to approve the purchase of a CAT bulldozer for **Road & Bridge, Precinct #3**,
through the Texas Buy Board, for \$69,986.00. All voted yes and none no. SEE
ATTACHED

Commissioner Walston and Joyce Moore had been in contact with Dr. Sandra Jackson
and the Social Security Administration concerning the outstanding bill for medical care
of a prisoner during Hurricane Rita. Mrs. Moore stated that since the prisoner's Medicaid
benefits did not cease until July 2006, she notified Spring Branch Medical Center to
submit the bill to Medicaid. No further action from the court was taken at this time.

Judge Blanchette proposed leasing port-a-potties to be used by prisoners from the Gib
Lewis Unit. While doing grounds maintenance at the courthouse, prisoners will not be
allowed to use the courthouse facilities for security reasons. **Commissioner Marshall**
motioned to authorize the lease of port-a-potties for a cost of \$90 per month from Lasso-
Septic & Sludge in Jasper, to be paid from the "**repairs to courthouse**" budget.
Commissioner Hughes seconded the motion. Commissioner Nash was concerned about
the location of the potties on the courthouse grounds in an unsightly place.

Commissioner Marshall motioned to amend his previous motion to include that Judge Blanchette would be in charge of the placement of the potties. Commissioner Hughes seconded the amendment. All voted yes and none no. Judge Blanchette was not in favor of the amendment.

Upon hearing the names to be appointed to the Tyler County Historical Commission, Sandi Hargraves reported this was not a current list. At least two of those persons had resigned. It was a consensus of the court to table this matter until a more recent list of members could be obtained.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Walston** to adopt the resolution in support of a **Community Development Block Grant** for disaster relief; and that Judge Blanchette set the date for the workshop at his discretion. All voted yes and none no. SEE ATTACHED RESOLUTION

After reading of the whole by Judge Blanchette, a motion was made by **Commissioner Walston** and seconded by **Commissioner Nash** to adopt the resolution in reference to management and nuisance of feral hogs and beavers. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made by **Commissioner Nash** and seconded by **Commissioner Walston** to approve a **gravel pit agreement** with Valerie Brown. All voted yes and none no.

A motion was made by **Commissioner Hughes** and seconded by **Commissioner Marshall** to appoint Daniel C Nicholson (upon confirming his ownership of property within district #6), James Alfaro, Latricia Deal, Shawn Deal, Roy McInnis and Douglas Moore to the board of commissioners for **Emergency Services District #6** (Fred); . All voted yes and none no.

Sheriff Wolf entered the meeting and updated the court as to the recent inspection by the jail commission. The present jail has a capacity of 40 inmates. He stated the Texas Commission of Jail Standards can do a study of costs and make recommendations to alleviate overcrowding, at no cost to the county. Judge Blanchette commented that housing federal prisoners would offset the cost of increasing the jail facility. Commissioner Walston mentioned the state was not planning to build mire prisons at the present due to lack of personnel. **Commissioner Hughes** motioned the approval of a cost study by the Texas Commission of Jail Standards. **Commissioner Walston** seconded the motion. All voted yes and none no.



Northeast Texas Beaver and Feral Hog Management Resolution Program**

Joint Resolution

WHEREAS, in Northeast Texas most large reservoirs, private lakes, and U. S. Army Corps of Engineers and U.S. Soil Conservation lakes have been constructed to provide water supply and recreational opportunities for hundreds of thousands of residents and visitors; and,

WHEREAS, beavers, a non-native Texas species were introduced in Northeast Texas by the Texas Parks & Wildlife Department as late as 1973; and,

WHEREAS, feral hogs are also a non-native Texas species, introduced to the area through a combination of accidental releases and intentional stockings; and,

WHEREAS, the feral hogs are prolific breeders, sometimes one hog producing up to 24 offspring in a single year. The beaver population has also changed to where they have shorter gestation periods; and,

WHEREAS, the increase in suitable habitat coupled with the species' reproductive patterns results in a surge in the population of these species in the 35 county Northeast Region to include Tyler County; and,

WHEREAS, local government officials in Northeast Texas have witnessed, with increasing frequency, property damage to roads, bridges, culverts, stock tanks and lakes along with significant agricultural damage resulting from the beaver introduction and the current surge of the population of destructive feral hogs. This damage can be especially dangerous to the agriculture production, potentially costing Texas economy millions of dollars in losses; and,

WHEREAS, feral hogs carry lethal diseases that can be transmitted to humans; and,

WHEREAS, feral hog activity is increasing along the state's highway system; at least two recent highway deaths in Navarro County and Wood County are attributed to feral hogs; and,

WHEREAS, the U.S. Department of Agriculture and Texas A&M Cooperative Extension Service and Cooperative Extension Program Wildlife Services Unit are the cooperating agencies in Texas to alleviate or mitigate damage caused by various wildlife species; and,

WHEREAS, the State's allocation to address the problem for the 2006-2007 biennium is inadequate to reduce the numbers of beavers and feral hogs in Northeast Texas. The total funding for wildlife control for the entire state is \$3 million per year; and

NOW THEREFORE BE IT RESOLVED, that additional manpower and equipment are desperately needed to alleviate the magnitude of beaver and feral hog destruction occurring in Northeast Texas, with the potential to spread to urban areas.

BE IT FURTHER RESOLVED, that the East Texas Council of Governments, Deep East Texas Council of Governments and the Ark-Tex Council of Governments requests and encourages the Northeast Texas State Legislative Delegation to provide additional manpower and equipment to the Wildlife Service Unit for the 2008-2009 biennium period for the expressed purpose of beaver and feral hog management control in the 35 county Northeast Texas region.


Specifically, it is requested that an additional 44.5 million be directed to the Northeast Texas region to hire 20 dual role wildlife specialists, furnish the necessary equipment, provide per diem and fuel costs and administrative costs for a two year period.




