A motion was made by **Commissioner Hughes** to approve an application to be submitted for a Violence Against Women special **prosecutor grant**, as requested by Joe Smith. The motion was seconded by **Commissioner Nash**. All voted yes and none no. This is the same grant as received in the past of \$60,000 by the **Criminal District Attorney**.

**Commissioner Nash** motioned to approve an application for a **Victims of Crime** grant which the county's match would be 20% of \$37,325. **Commissioner Walston** seconded the motion. All voted yes and none no. This is the same grant as received in the past that pays the salary of one secretary in the department of the **Criminal District Attorney**.

Commissioner Walston motioned to repair the speaker system at the "drive through" window at the **tax office**. The cost is \$1237. **Commissioner Nash** seconded the motion. All voted yes and none no.

Lynette Cruse reported the lack of **security** at the **tax office**. Due to the large amounts of money her office handles, the employees would like an alarm system in their work space. She requested an alarm system be installed for the employees and lighting for the outside of the building. The County Auditor stated that this could not be paid with "courthouse security" funds because the building did not house a courtroom. **Commissioner Walston** recommended getting more than one bid and motioned this item be tabled for further study. **Commissioner Nash** seconded the motion. All voted yes and none no.

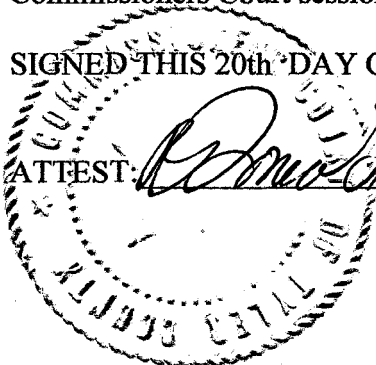
Commissioner Walston motioned the meeting adjourned. Commissioner Hughes seconded the motion.


